Becoming ADA Compliant is Easy with MTI

To improve access to care for people with disabilities the U.S. Department of Health and Human Services ("HHS") and the U.S. Department of Justice ("DOJ") issued final rulings requiring medical and dental offices, clinics, emergency rooms, hospitals, and other healthcare settings to ensure that at least one, and up to 10%–20%, of your examination chairs comply with the ADA's MDE standards by July 8, 2026 and August 9, 2026, respectively.

Critical Requirements

Some of the key requirements for an ADA Compliant examination chair are a 17" – 19" entry height, a transfer support, a 21"×17" transfer surface, and leg supports where stirrups are required. Wth your MTI chair, you can rest assured that these requirements are met. ¹

To help implement these standards, the IRS has issued Section 44 Disabled Access Credit (also known as the ADA Tax Credit), which may provide a tax credit of up to \$5,000 for ADA Compliant examination chairs.¹

Ensuring Compliance

Facilities recieving federal funding assistance (HHS), including payments from Medicare, Medicaid, and CHIP, and state and local governments (DOJ) must meet requirements by the dates to the right.
